**Declare trailer surplus:** The Public Works Department requests authorization to surplus one 10-foot utility trailer to be replaced by a 14-foot trailer that can carry two mowers to City owned properties. Staff recommends the minimum bid be \$600.00.

**Utility Trailer Purchase:** The 2022 Parks and Playgrounds Capital Equipment budget includes \$2500 for a new utility trailer. Staff contacted several vendors and received three quotes for a new trailer. I 90 Enterprises submitted the lowest responsible quote at \$2850.00. This cost would be offset by auctioning off a current utility trailer with an estimated value of \$600.00. Staff requests authorization to purchase the trailer from I 90 Enterprises for \$2850.00.

Reimbursement Resolution: The lead lateral replacement project requires the replacement of many public side (from the shut-off to the main) laterals this year. The cost of these replacements is not DNR grant eligible and must be funded by the Water Utility. The Utility Commission recommended proceeding with the public side lateral project and that it be funded with the DNR subsidized loan program, the Safe Drinking Water Program. The attached resolution allows the city to fund the project in from utility cash until the loan proceeds are available in 2023.

**Pollinator plants in Pottery Plaza:** Two of the mounds in the garden in front of city hall need to be replanted. Staff recommends the city plant low growing pollinator plants. Given the slope of the mounds and the relatively slow maturation of native plants, staff also recommends the plantings be with "plugs" (small plants), as opposed to seeds. The estimated cost of this planting is \$350. Funds could be taken from the residual account from the construction of city hall.

**No Mow May:** Advocates for landscapes that support pollinators, suggest lawns not be mowed in the month of May as some of the plants in lawns "carry" the pollinators through until summer plants are available for the pollinators. If the Council wishes to allow residents to participate in "No Mow May", the Council should make a motion directing staff to not issue citations for lawns that exceed the height limitations during the month of May.

#### CITY OF EDGERTON DECLARATION

#### RECOGNIZING MAY 11–17, 2022 AS POLICE WEEK

WHEREAS, there are more than 800,000 law enforcement officers serving in communities across the United States, including the dedicated members of the Edgerton Police Department;

WHEREAS, since the first recorded death in 1786, more than 23,000 law enforcement officers in the United States have made the ultimate sacrifice and been killed in the line of duty;

WHEREAS, the names of these dedicated public servants are engraved on the walls of the National Law Enforcement Officers Memorial in Washington, DC;

WHEREAS, 619 new names of fallen heroes are being added to the National Law Enforcement Officers Memorial this spring, including 472 officers killed in 2021 and 147 officers killed in previous years;

WHEREAS, the service and sacrifice of all officers killed in the line of duty will be honored during the National Law Enforcement Officers Memorial Fund's 34<sup>th</sup> Candlelight Vigil, on the evening of May 13, 2022;

**WHEREAS**, the Candlelight Vigil is part of National Police Week, which will be observed this year May 11-17;

WHEREAS, May 15 is designated as Peace Officers Memorial Day, in honor of all fallen officers and their families and U.S. flags should be flown at half-staff;

**THEREFORE, BE IT RESOLVED** that the City of Edgerton will observe May 11-17, 2022, as National Police Week in Edgerton, Wisconsin, and publicly salutes the service of law enforcement officers in our community and in communities across the nation.
