Re: Funding for Private side Lead Laterals

Use of Rate Payer funds for private lead laterals: Please recall the Commission voted to use rate payer funds to pay for 50% of cost to replace private lead laterals serving properties that are not eligible for the WDNR grant program. (Non-residential properties are not eligible for DNR grant funding.) At the time the Commission made that decision, staff estimated that there could be 26 commercial/non-residential properties with private-side lead laterals. Since that time, staff has inspected almost all commercial properties and now believes that there are no more than 10 properties with lead laterals that are ineligible for the DNR grant program.

To use rate payer funds to pay for private laterals, the Commission would have to get PSC approval. Staff began the PSC application process and learned it takes 3-6 months to obtain PSC approval and the statutory restrictions may result in denial of the application. Considering these hurdles and because we have very few properties with lead that are not eligible for the DNR grant, staff is recommending the Commission request the City Council not pursue PSC approval to use rate payer funds for private lead lateral replacement. Funding options include 100% ARPA (federal stimulus) funds and /or special assessments.

- 1. Monthly samples were taken to the State Lab of Hygiene. All samples were safe.
- 2. Fixed a main break on W Ladd Ln. One six inch repair band was used.
- 3. Packing was changed at #3 and #4. Also changed oil and greased motor.
- 4. The hydrant on the corner of W Fulton and Maple was hit. There is a two foot extension on this hydrant. We will have to dig down over two feet to unbolt it and repair it. We will do this when the frost is gone.
- 5. Continuing to inspect houses for lead service lines.
- 6. Replaced a bad wall outlet at #2. This was causing the fluoride and chlorine pumps to not pump at times. Nobody was electrocuted.
- 7. Priming and painting of all three wellhouse floors is partially finished.
- 8. Locates were done.
- 9. Monthly DNR report was submitted.
