SEPTEMBER 16, 2024 PUBLIC SAFETY COMMITTEE MEETING MINUTES CITY OF EDGERTON

Jim Burdick called the meeting to order at 6:16 p.m. Committee members present were Jim Burdick, Tim Shaw, and Paul Davis. Also present were Mayor Chris Lund, Police Chief Robert Kowalski, City Administrator Ramona Flanigan, and Alderperson Candy Davis.

Flanigan confirmed the agendas were properly posted on Friday, September 13, 2024 at the Post Office, Edgerton Library, City Hall and the City's website.

APPROVAL OF PUBLIC SAFETY MINUTES:

A Tim Shaw/Paul Davis motion to approve the March 4, 2024 Public Safety Committee meeting minutes passed, all voted in favor.

ELECT CHAIR:

A Tim Shaw/Paul Davis motion to elect Jim Burdick as chair, passed on a 3/0 roll call vote.

DISCUSS AND UPDATE RAPID FLASHING CROSSING SIGNS:

Chief Kowalski stated that in his opinion we could use two more rapid flashing signs. It was discussed to add a sign stating cross walk ahead Eastbound on W Fulton St. Chief Kowalski said he will get a quote for two more rapid flashing signs.

DISCUSS CAPITAL EQUIPMENT EXPENDITURES FOR 2025 BUDGET:

Chief Kowalski stated that items requested in the budget are a 2025 Ford Police Interceptor, two mobile radio units, and two mobile radars.

DISCUSS AND UPDATE EMERGENCY CALL BUTTON OUTSIDE OF POLICE STATION:

Chief Kowalski recommends holding off on adding a call button outside of the Police Station. Installation would be at least \$1,000 and \$35.00/month for the service.

DISCUSS NEWLY ASSIGNED SCHOOL RESOURCE OFFICER:

Chief Kowalski stated that McKaylie Buescher is doing a great job and building a great bond with the School District.

DISCUSS CELLPHONE FOR SRO:

Chief Kowalski stated with the new AT&T cellphone tower near the schools it would make the most sense to switch to that coverage for better reception.

POLICE CHIEF REPORT:

Chief Kowalski stated that the Police Department is currently in the hiring process to fill a Police Officer vacancy.

Being no other business before the Public Safety Committee, a Tim Shaw/Paul Davis motion to adjourn passed, all voted in favor.
