RACETRACK ADVERTISING SIGN POLICY: The current policy for the advertising signs at Racetrack Park prohibits advertising that contains tobacco or alcohol emblems. Tobacco Heritigage Days requested an exception to the policy to allow two advertising signs that include tobacco leaf illustrations.

A Langan/Furseth motion to change the advertising sign policy language from "tobacco or alcohol emblems" to "tobacco or alcohol products and/or logos" passed on a 5/0 roll call vote.

**Skatepark location:** As requested at the last Parks meeting, staff will stake out two possible areas at Racetrack Park for a skatepark: one near the deer pen and one near the former tractor pull area. The Committee will go to Racetrack Park to review the options.


**West Meadows Park**: The Edgerton Rotary Club is interested in funding, and providing in kind maintenance services, to remove invasive species from West Meadows Woods, which is a city park. The park is located on the SW corner of W Fulton and Menhall Drive.


The Rotary Club has met with a forester and some local companies who work in forest management. The Club will contract with an experienced company to undertake the large initial task of removing the invasive trees and treating the stumps so they do not regenerate. After the removal is done, the Rotary Club has expressed interest in "adopting" the park for ongoing care. If the Rotary Club agrees to undertake some on-going care of the park, the Club is interested in placing signage at the park indicating the Rotary Club has "adopted" the park. This type of arrangement does not fall into the City's adopted policy regarding donations, so the Parks Committee should consider if it will allow park adoption and what recognition would be allowed.

**Bat houses at Racetrack Park:** A student of Edgerton HS is spearheading a project to build and install bat houses at Racetrack Park. The student will present the idea to the Parks Committee.

Lateral Pay for lifeguards: The Pool Directors are seeking permission to offer a \$1 / hour higher starting wage for lifeguards with prior experience from another facility (\$12.50 instead of \$11.50). The Directors feel that the increase is warranted and would be helpful in attracting these experienced guards. The estimated increased cost would be approximately \$300 / employee. The Committee should also decide if the Directors have the authority to offer starting wage increases for experienced lifeguards without Committee approval in the future.

**Fish Pond Pier:** The Conservation Club wishes to present ideas about extending the pier at Fish Pond Park.
