AUGUST 15, 2022 PUBLIC WORKS COMMITTEE MEETING MINUTES CITY OF EDGERTON

Chairperson Jim Burdick called the meeting to order at 6:00 p.m.

Committee members present were Jim Burdick, Casey Langan and Sarah Braun.

Also present were City Administrator Ramona Flanigan, Municipal Services Director Howard Moser and citizens.

Moser confirmed the agendas were properly posted on Friday, August 12, 2022 at the Post Office, Edgerton Library, City Hall and the City's website.

APPROVE MINUTES: A Burdick/Braun motion to approve the July 18, 2022 Public Works Committee minutes passed on a 3/0 roll call vote.

SIDEWALK UTILITY CREATION AND ORDINANCE: Staff presented key definitions for the following terms related to the sidewalk utility ordinance: developed parcels, undeveloped parcels, and equivalent unit (EU). Developed parcels: The sidewalk utility applies to all properties that have public sidewalk; almost all properties that are improved; and vacant developable lots that are not part of a recent subdivision. Undeveloped parcels such as parcels too small to be developed, wetlands, buildings built over lot lines, steep slopes, land that is not platted, large farm parcels and/or platted subdivisions before building permits are issued are not subject to sidewalk utility charges. The average frontage of residential lots is an Equivalent Unit (EU) of 100 ft.

The Committee went on to discuss changes to the proposed ordinance. Line "D" in section 366-65 Rates and Changes was updated to state, "The Sidewalk Utility shall pay 50% of the costs of the installation of new sidewalk in existing neighborhoods". In regards to line "E", number 5 in section 366-68 Customer Classifications it was clarified that 0-100 linear feet equals 1 EU, 101-200 linear feet equals 2 EU, 201-300 linear feet equals 3 EU and so forth.

The following policies were discussed and approved: City parcels should not be included in the sidewalk utility so costs are spread to all properties, not just tax payers; the Equivalent Unit (EU) will be \$11 per year; a cap will not be established on nonresidential parcels; and utility funds will not be used in private developments and along private roads.

A Burdick/Langan motion to recommend the Sidewalk Utility Ordinance to the Council passed on a 3/0 roll call vote.

Being no other business before the Committee, a Braun/Langan motion to adjourn passed, all voted in favor.

Quigley Street rehabilitation: Quigley Street is scheduled for rehabilitation in 2023. The project will consist of spot curb repair and the replacement of sewer, water and street system. The ordinance requires sidewalk be installed where sidewalk does not exist for reconstruction projects. A reconstruction project is defined as a street project that includes the replacement of at least 50% of the curb where curb exists, or when curb is being install for the first time on 50% of the street frontage.


The project will not replace more than 50% of the existing curb between Reinhold and Lord Street, and therefore does not meet the definition of a reconstruction project. The section of Quigley east of Reinhold does not have curb and would meet the definition of reconstruction. There is currently no sidewalk on Quigley Street.

Policy questions:

- Should curb and gutter be installed east of Reinhold? Staff recommends curb be installed. Customarily, the cost of new curb is paid for by the adjoining property owner through special assessments. If the committee recommends the new curb be paid for through special assessments, a public hearing would be held by the Council.
- 2. Should sidewalk be installed on Quigley Street east of Reinhold? This would be the only section of sidewalk on Quigley. If the sidewalk utility is approved, 50% of the cost of sidewalk would be paid for by the utility and 50% would be paid for by the home owners through a special assessment.

Please note, the project will include a turnaround within the ROW and a much narrower street section east of Reinhold.
