Also attending was Police Chief Kowalski and Mayor Chris Lund. This meeting was held in person at City Hall and was available virtually.

Coombs confirmed the agenda was posted properly for this meeting at City Hall, the Library and the Post Office on Friday, December 10, 2021.

#### **MINUTES:**

Venske/Davis motion to approve the May 27, 2021 Police Commission Meeting Minutes passed, all voted in favor.

**UPDATE ON OFFICER HANNA REUTER:** Officer Reuter has fulfilled all training requirements as agreed, graduated from the Academy with exceptional scores and is certified as a Patrol Officer. She will continue her part-time duties until a full-time position is available.

**DISCUSS PART TIME TO FULL TIME OFFICER POSITION:** The process of offering and approving a part time officer to a full-time position was discussed and decided. A special meeting of the Police Commission will be called.

**UPDATE ON OFFICER BRANDON SWINBANK:** Officer Swinbank is progressing through his probationary period with nothing but high regards from co-workers and superiors. His work and special interests are an asset to the Edgerton Police Department.

**DISCUSS OPEN LT POSITION:** Chief Kowalski reviewed the process of posting, assessing and interviewing candidates for the open Police Lieutenant position. Information will be provided to the Police Commission and a special meeting will be called.

#### **POLICE CHIEF REPORT:**

Chief Kowalski gave a detailed report on the City of Edgerton Police Department and its Officers.
