2023 BUDGET: The City's maximum levy increase for 2023 is \$15,734. The current draft of the budget shows a \$29,384 exceedance from the levy increase. Options to reduce this exceedance were presented to the Council.

The current budget includes funds for a School Resource Officer. The School District has not approved this expenditure. The cost of the SRO could be funded by the contingency fund.

Casey Langan suggested removing the funbrella and bleachers until after the parks plan has been approved.

Candy Davis suggested using ARPA funds to fund the pedestrian improvements.

A Candy Davis/Jim Burdick motion to approve using ARPA funds for the rapid flashing pedestrian lights and the programmable flashing pedestrian signs in the amount of \$18,200 passed on a 6/0 roll call vote.

A Candy Davis/Sarah Braun motion to use \$11,184 of the Contingency Fund to balance the budget passed on a 6/0 roll call vote.

CLOSED SESSION: Casey Langan/Candy Davis moved to go into closed session pursuant to Wis. Stat. pursuant to Wis. Stat. 19.85(1) (e) "Deliberating or negotiating the purchasing of public properties, the investing of public funds, or conducting other specified public business whenever competitive or bargaining reasons require a closed session." OCTOBER 24, 2022 JOINT COMMON COUNCIL AND PLAN COMMISSION MEETING MINUTES CITY OF EDGERTON

Mayor Christopher Lund called the meeting to order for the City Council at 6:30 p.m.

Commission Chair Christopher Lund called the meeting to order for the Plan Commission at 6:37 p.m.

Present: Chris Lund, Jim Burdick, Paul Davis, Theran Springstead, Jim Kapellen, Julie Hagemann, and Ron Webb.

Others Present: City Administrator Ramona Flanigan, and a few citizens.

Flanigan confirmed the meeting agendas were properly posted on Friday, October 21, 2022 at the Post Office, City Hall, City website, and the Edgerton Library.

PUBLIC HEARING: The Council and Plan Commission held a public hearing to gather public input on the request by JGP Land Development to amend the City of Edgerton Comprehensive Plan for a portion of the unplatted area south of Orchard Heights Subdivision from Institutional and Single Family residential to Multi-family residential (parcel 6-26-1410).

Flanigan stated the request is for an amendment to the Comprehensive Plan. The application addresses 14 of the 62 acres that are undeveloped in what is known as the Orchard Heights neighborhood. The request is to replan 7 of the 14 acres from an institutional use to a multifamily use. The other 7 acres are currently planned as single family. The applicant is requesting to replan those to multi-family use. The remainder of the 62 acres will remain single family.

Kyle Carrier, 893 Stonefield, spoke as a representative for JGP Land Development. He stated the main reason this change is being requested is because of the lot cost. Multi-units will lower the cost by spreading the costs amongst everything. Another reason, is increasing the tax base would benefit everyone. This would also relive the rental shortage in the municipality by offering rental units and also help the housing shortage.

Citizens from the current Orchard Heights subdivision spoke regarding concerns about the increase in traffic, they were concerned with the speeding issues that could ultimately cause traffic accidents. They also asked about additional traffic control signage at the entrance to the new development.

Stephanie Decker, 533 Falk Dr stated she felt the planned development would cause a congestion of vehicles coming and going from the subdivision with only 2 entrances/exits. She feels the current plan it is too dense with houses.

George Decker, 533 Falk Dr, felt the influx of cars in the subdivision will cause problems with congestion, speeding and accidents. He also stated that although it would bring more tax base, it would also cause a bigger need for services and those services come at a cost to the tax payers.

Lucas Canik, 405 Lorraine Dr, stated the neighborhood was not notified this was going to happen and feels there may be more citizens that have opinions on this topic. He stated the traffic gets congested already during a soccer game at the subdivision's park. With the influx in traffic with this new subdivision it will be worse.

A homeowner from the subdivision stated he was not aware this hearing was being held until the night before. He felt there should have been better communication allowing the homeowners time to do research on the development. He was told notices went out to each homeowner well over a month ago, the public hearing notice was published in the paper and the meeting was posted in the required locations.

Mayor Lund read an email into the record from Colette Spranger from 304 Dorow Ave. She was in favor of the amendments.

Ramona Flanigan stated, this meeting is only to amend the Comprehensive Plan. The next step would be a public hearing to have the parcels re-zoned. If the re-zone is approved then the platting process needs to happen. This process timeline would depend on the developer.

Hearing no further comments, the Mayor closed the public hearing.

PLAN COMMISSION ACTION ON RESOLUTION 20-22: Julie Hagemann stated she also had concerns regarding the traffic congestion with the multi-family homes in that neighborhood. She would also like to see the data on housing compared to communities similar to ours.

Jim Kapellen/Theran Springstead moved to approve City of Edgerton Resolution 20-22: Recommending the amendment to the City of Edgerton Comprehensive Plan to allow 7 acres of the unplatted area south of Orchard Heights Subdivision be changed from Institutional and Single Family residential to Multi-family residential. (parcel 6-26-1410)

The motion passed on a 5/1 roll call vote. Julie Hagemann voted against the motion.

Chamber Lease of the Depot: The Chamber's lease of the Depot has expired. The attached lease is for three years with two, one-year extensions and has similar terms as the previous lease.

Depot Sublease with Coffee Depot LLC: Edge Events, the current sublease holder of the depot, wishes to terminate their lease. The current operator of the coffee shop in the depot wishes to sign a lease for the building. The Chamber of Commerce, the Depot Tenant, has negotiated the sublease terms and rates.

Resolution 21-22: To address the Fire District levy limit exceedance in the 2022 budget, the Council has to amend the budget.

TIF #8 Termination: Please recall the Council extended the life of TIF #8 to provide one year's worth of increment for the Revive Edgerton Affordable Housing Program. After the Revive Edgerton allocation is complete, the TIF will have collected adequate funding to retire the district. A resolution is required to terminate the TIF.

Policy for funding new curb: The current practice regarding the construction of new curb where curb does not exist, is the adjoining property owner pays 100% of the cost of new curb. The policy for new sidewalk that was recently adopted as part of the Sidewalk Utility is adjoining property owners pay 50% of the costs of the installation of new sidewalk and the Sidewalk Utility pays the other 50%.

The policy question is, should the Stormwater Utility pay 50% (or some other percentage) of the cost of new curb where curb was not previously installed or should the City continue the past practice of requiring the adjoining property owner pay 100% of the cost of new curb?

15 N Main Street (Bumper to Bumper Store) and 25 N Main Street (former Citgo): The owner of 15 and 25 N Main Street received two grants for paving: one in the amount of \$9,920 to pave the gravel parking lot at 25 N Main Street (work is complete); and a second grant for a portion of the vacant lot between 15 N Main and 25 N Main Street in the amount of \$7,200 (Shown as cross hatched in the attached map. Work will be done in the spring).

The owner now wishes to complete the paving of the vacant lot between 15 N Main St and 25 N Main St and is seeking a façade grant (circled area in the attached map). The estimated cost for the "circled" area is \$29,232. If awarded, the maximum grant amount would be \$5,000.

RESOLUTION 23-22

CITY OF EDGERTON RESOLUTION RECOGNIZING LEAD IN DRINKING WATER IS A PUBLIC HEALTH HAZARD AND DECLARING A COMMITMENT TO REPLACE 100 PERCENT OF LEAD SERVICE LINES OVER THE NEXT FIVE YEARS

WHEREAS, there are various sources of lead in households and in the environment that can pose a risk to human health, including, but not limited to, lead in drinking water, paint, dust, air, soil, and so on; and

WHEREAS, there is no safe level of exposure to lead, as determined by the U.S. Environmental Protection Agency and the Centers for Disease Control and Prevention; and

WHEREAS, children under the age of six are especially susceptible to the health effects of lead exposure which, as a heavy metal and a neurotoxin, can lead to lifelong intellectual, emotional, and behavioral consequences including decreased IQ, hyperactivity, hearing problems, stunted growth, and learning disabilities; and

WHEREAS, adults are also vulnerable to lead exposure, leading to an increased risk of cardiovascular disease, hypertension, and organ failure; and

WHEREAS, the exposure of pregnant women to lead can cause a fetus's prenatal exposure, resulting in stillbirth, miscarriage, and developmental delays; and

WHEREAS, lead-based plumbing+, including lead service lines, can pose a threat to public health and in particular to safe drinking water, not only in communities across the country but also in the City of Edgerton; and

WHEREAS, lead service line means any piping, tubing, and fittings connecting a water main to a home or building that serves a customer of a water system, and includes the private/homeowner side and the public/system side of a service line; and

WHEREAS, the largest opportunity to dramatically reduce the risk of exposure to lead in drinking water is to replace the lead service lines that bring water to individual homes and buildings from the public water main; and

WHEREAS, The City of Edgerton is aware that there are an estimated 100 lead lines within the City of Edgerton's water service system, on both public and private property, as it was once a common practice to install lead pipes, lead connectors, and other lead components in water systems; and

WHEREAS, the U.S. Environmental Protection Agency found that partial service line replacement, in which only the public side of the lead service line is replaced, can pose an increased risk of elevated lead levels in water and the potential for harm; and

WHEREAS, for many homeowners, especially in the City of Edgerton, replacing the homeowner or private side of the lead service line is cost prohibitive without financial assistance, and federal funds through the Bipartisan Infrastructure Law of 2021 allow for full service line replacement; and

WHEREAS, full lead service line replacement, in which the entire line is replaced from main to the individual house/building, can result in reliable, long-term reductions in lead in drinking water; and

WHEREAS, every resident of the City of Edgerton deserves access to clean and safe drinking water free from the risk of lead contamination, especially since the solution is available through full service line replacement; and

WHEREAS, the U.S. Environmental Protection Agency's Lead and Copper Rule Revisions, promulgated in December 2021, requires that all water systems, including in the City of Edgerton, conduct an inventory of lead service lines by October 2024; and

WHEREAS, funds going to municipalities from American Rescue Plan of 2021 can be used for water infrastructure projects such as lead service line replacement and additional federal funding through the Bipartisan Infrastructure Law of 2021 is available for the next five years for "lead service line identification, planning, design, and replacement" through State Revolving Funds; and

NOW, THEREFORE, BE IT RESOLVED, The City of Edgerton seeks to complete a lead service line inventory and a plan for replacement so that 100 percent of lead service lines can be replaced within the next five years and the residents of the City of Edgerton can enjoy lead-free drinking water for now and for future generations; and

BE IT FURTHER RESOLVED, The City of Edgerton recognizes that lead service line replacement begins with an understanding of the number and location of service lines containing lead, and therefore the Edgerton Utility Department seeks to complete a thorough, transparent inventory within one year in order to speed up the process of lead service line replacement; and

BE IT FURTHER RESOLVED, The Edgerton Utility Department has developed a lead service line replacement plan containing the estimated costs, cost-saving approaches, and a financial plan to identify and secure funding to ensure all households, especially low-income ones, can participate in full service line replacement; and

BE IT FINALLY RESOLVED, The City of Edgerton hereby directs the Edgerton Utility Department to ensure that the plan to replace lead service lines includes a prioritization of local workforce development and procurement and a prioritization schedule for replacement in vulnerable neighborhoods and among vulnerable populations.
