**Pool operations**: Based on data available so far, we estimate the impact on the budget will be approximately \$15,000-\$20,000 worse than we anticipated in the original 2020 budget.


Henderson Special Assessments: As part of the resurfacing of Henderson Street, a cul-de-sac will be added to end of the street. This project was included in the 2020 budget and was awarded with the construction contract earlier this year. According to City policy, improvements being installed for the first time are assessable to the benefiting property owner. A portion of the costs of the following improvements are being assessed: pavement and base, driveway apron, curb and gutter, and gravel for the driveway. The City Council will hold a public hearing regarding special assessment charges to the benefitting property owner for the project.

There is one landowner listed on the attached preliminary special assessment schedule. The resolution included in your packet requires the Council determine the <u>interest rate</u>, the <u>minimum assessment amount that will be financed</u>, and the <u>number of years</u> the owner will have to repay the special assessment. The most recent assessment that included new sidewalk and curb and gutter was on Chaucer Street in 2018. The terms assigned to Chaucer Street special assessments were 3.5% with a 10 year term. The minimum payment to be financed was \$200.

Shared Ride Taxi partition: The Council approved \$260 for the purchase of a partition to be installed between the front and back seats of the shared ride taxi to protect drivers and riders from COVID 19. The divider was not purchased. A new version of the divider is now being proposed that provides better protection. The cost of new divider is \$380.

**102** W Fulton Façade Grant Amendment: The City approved a Façade grant for 102 W Fulton (C&M Printing). The grant did not include funds for the front step repair. The applicants are requesting the repair be included in the award. The additional grant amount would be \$433.80.

**Liquor License Amendment for 520 N Main:** The owner of the establishment at 520 N Main wishes to have a 16x28' beer garden on the Swift St side of the building. The proposed liquor license amendment adds this area to the description of the premise for the license.



#### CITY OF EDGERTON RESOLUTION No. 11-20

## PRELIMINARY RESOLUTION DECLARING THE CITY COUNCIL'S INTENTIONS FOR THE HENDERSON STREET CUL-DE-SAC PROJECT TO EXERCISE SPECIAL ASSESSMENT POLICE POWERS UNDER SEC. 66.0703 WIS. STATS.

The Common Council of the City of Edgerton, Rock and Dane County, Wisconsin, does resolve as follows:

- 1. The Common Council hereby declares its intention to exercise its police power under Sec. 66.0703 Wis. Stats. to levy special assessments upon property in accordance to the attached assessment schedule for the Henderson Street Cul-de-sac Project conferred upon such property.
- 2. The public improvements shall include the installation of a cul-de-sac for properties at the end of Henderson Street listed in the attached schedule.
- 3. The total amount assessed against the properties in the defined assessment district shall not exceed one hundred percent (100%) of costs associated with the cul-de-sac work. The Common Council determines that the improvements constitute an exercise of the police powers and the amount assessed against each parcel shall be based on the actual cost of the work.
- 4. The assessment against any parcel within the corporate limits of the City of Edgerton may be paid in cash or may be paid in \_\_\_\_\_annual installments if the assessment is \_\_\_\_ or more. Installment payments for parcels within the corporate limits of the City bear interest of \_\_\_\_\_. Installments not paid when due shall bear additional interest on the amount due at the rate of twelve percent (12%) per annum.
- 5. The Municipal Services Director shall prepare a report, which shall consist of:
  - (A) Preliminary plans and specifications for the improvements.
  - (B) An estimate of the entire costs of the proposed project improvement; and
  - (C) A schedule of proposed assessments.
- 6. When the report is completed, the Municipal Services Director shall file a copy of the report with the City Clerk for public inspection; and the State Board of Commissioners of Public Lands, and the State Department of Administration, and the State Building Commission, if necessary.
- 7. Notice of the proposed special assessment will be published once in the EDGERTON REPORTER and a copy mailed to every interested person whose post office address is known or can, with reasonable diligence, be ascertained, not less than ten (10) nor more than forty (40) days before the hearing.

- 8. Upon receiving the report of the Municipal Services Director, the City Clerk shall cause notice to be given stating the nature of the proposed improvement, the general boundary lines of the proposed assessment district, the time and place at which the report may be inspected, and the time and place of the public hearing on the matters contained in the preliminary resolution and the report. This notice shall be published as a Class 1 Notice and a copy shall be mailed, at least ten (10) days before the hearing, to every interested party.
- 9. The public hearing shall be held at the Edgerton City Hall, 12 Albion Street, Edgerton, WI 53534 at a time set by the Clerk/Treasurer in accordance with Sec. 66.0703(7), Wis. Stats.

### JULY 20, 2020 COMMON COUNCIL MEETING MINUTES CITY OF EDGERTON

Mayor Christopher Lund called the meeting to order at 7:07 p.m.

Hegglund confirmed the meeting agendas were properly posted on Friday, July 17, 2020 at the Post Office, City Hall, Edgerton Library and City's website.

**SWIMMING POOL UPDATE:** Aquatics Director Anne Gohlke updated the Council on the day to day operations of the pool. Gohlke provided a 5-year average of number of patrons and pool revenue. So far in 2020 the number of pool patrons and pool revenue for daily passes has exceeded the 5-year average.

The adult lap swim and water aerobics times were adjusted to add more slots. A "sign-up genius" was utilized to schedule times for those sessions. The staff has not had to turn any patron away and patrons have been very appreciative that the pool is open.
